

As the economy made a steady recovery, the hospitality and entertainment

industries also continued to gain strength.

Increased activity across the board,
particularly in the food and beverage sector,
as well as increased attendance helped
our venues exceed their revenue forecasts.

Cobb Energy Performing Arts Centre and
Cobb Galleria Centre were once again major
contributors to the economic wellbeing of
Cobb County and the state of Georgia.

In Fiscal Year 2023, our venues hosted a combined total of 413 events and performances with a total of 426,000 attendees and together generated an economic impact of \$169 million on Cobb County and the state of Georgia.

Talented students from 51 schools across the state of Georgia competed in the 15th annual Georgia High School Musical Theatre Awards, produced by ArtsBridge Foundation, the arts education and community outreach arm of Cobb Energy Performing Arts Centre. As a nonprofit organization, ArtsBridge has provided a variety of education initiatives for nearly 425,000 students and educators, often times subsidizing transportation and admission.

Looking back at everything we've accomplished this year, I am amazed by the tremendous commitment of the men and women who work in our venues and for our Foundation. As always, our employees went beyond the expected to achieve the extraordinary for our clients, patrons, and our donors.

COBB GALLERIA CENTRE

Over the past 29 years, Cobb Galleria Centre has evolved into one of the region's strongest economic engines and has continued to act as a catalyst for tourism and development within Cobb County. Fiscal year 2023 proved to be the year for our legacy clients to experience a steady comeback, increasing exhibitor participation and overall attendance. We were excited to welcome several firsttime conventions and tradeshows that have already made plans to return in 2024 and beyond. A few of the highlights included the National Association for Campus Activities (NACA), Gypsum Management and Supply, RecruitMilitary, Skillshot Media, A 5 Volleyball Club, TRIB Group, International Biomass Conference & Expo, TAPPICon, Alpha Kappa Alpha Sorority, Southeast Pet, and the National Pawn Brokers Association.

The Master Planning process is underway for the design, programming and reimagining of the convention center and the adjoining
Galleria Specialty Shops. The "Big Idea" will
be transformative by expanding the existing
footprint with new meeting rooms, outdoor event
spaces and glass enclosed pre-function areas.

A new fire alarm system was completed this year and over the next 12 months the moveable partitions in the exhibition halls and ballroom will be replaced and the escalators and elevators will be modernized.

We partnered with the Cumberland Community
Improvement District to launch the Cumberland
Hopper, an autonomous shuttle pilot program
provided to the community as part of a major
mobility project called the Cumberland Sweep.
The pilot program runs through March 2024. The
Cumberland Hopper is free of charge and stops
take place at the Cobb Galleria Centre.

COBB ENERGY PERFORMING ARTS CENTRE

2023 was another year of back-to-back shows, many of which were sold out. The highlight of the year was the Sweet 16 Anniversary Celebration. Since opening our doors on September 15, 2007, we have welcomed performers and performances of every imaginable genre, including plays, comedy, Broadway musicals, dance, rock, awards shows and more. It is this diverse mix that has made Cobb Energy Centre the go-to-venue in this region.

A few of the of the record-setting performances included five sold-out shows by Jim Gaffigan, two sold-out shows by Taylor Tomlinson, two sell outs of New Jack City by Je'Caryous Johnson and one-night sold-out performances by Summer Walker, Druski, Franco Escamilla, Atlanta Blues

Festival, Frankie Valli, Fortune Feimster, Fonseca, Anjelah Johnson-Reyes, and Rodney Carrington. The Centre has evolved into an internationally renowned venue after hosting the Headies Awards for the second year. The Headies were part of a bigger line-up of awards show including the BET Hip Hop Awards, WCLK's inaugural Jazz Awards, Georgia High School Musical Theatre Awards, and Black Music Honors.

Our resident companies The Atlanta Opera and the Atlanta Ballet continued to build new audiences and introduce new works. Ballet lovers enjoyed the return of Atlanta Ballet's larger-than-life production of The Nutcracker, and The Atlanta Opera's season included the ambitious new production of Das Rheingold, the first of four music dramas that comprise the grandest of all operas: Wagner's Ring cycle.

The Kessel D. Stelling Ballroom remained a preferred destination this year hosting some of Atlanta's most prominent corporate and social events including Synovus, ArtsKSU Gala and the ArtsBridge Foundation's Overture Gala.

This was the year for extensive upgrades to the audiovisual network and video distribution infrastructure within the theater, lobbies, and back of house spaces. A high-quality camera was installed in the theatre that can distribute video to displays throughout the venue. These upgrades were part of a 10-year capital improvement plan that will ensure the Cobb Energy Performing Arts Centre remains relevant and state-of-the-art.

INTERGOVERNMENTAL REVENUES

Debt service for Cobb Galleria Centre is provided for by a portion of the Hotel/Motel and Liquor by the Drink Taxes collected by Cobb County and the municipalities within the county. The Authority has entered into separate agreements with the county and municipalities in which all or a portion of the Hotel/Motel and Liquor By The Drink Tax collections are remitted directly to the Authority's Bond Trustee for debt service. Remaining amounts fund the Authority's contractual payments to the county and municipalities and provide funding for Cobb Travel & Tourism.

One for the thumb! The 15th annual Georgia High School Musical Theatre Awards won a fifth Southeast Emmy® Award for its special event live production. Thousands of students attended field trips to Cobb Energy Centre to learn how magic is scientific, how Beauty fell in love with the Beast, and how visual art can be made while dancing and singing! A Llama Llama LIVE! production, based on the bestselling book, provided the youngest students with reading, thinking, and decision-making tools, while older students enjoyed the dance and culture of the ZuZu African Acrobats – all the way from Tanzania! Following each field trip, every attending student received a nutritious snack pack, to assist their hunger pangs.

ArtsBridge debuted a new program, Theatre: Inside-n-Out, which introduced students to the technical side of theatre, exploring such things as sound, lighting, and staging. The program, which fills a critical learning gap, was very well received. Broadway and movie

star Gabriela Garcia traveled from New York City to teach two master classes – one in the style of "In the Heights" and the other in the style of "Chicago" – and participated in an intimate Q&A session.

ArtsBridge's annual fundraising event, the
Overture Gala, raised a record-setting \$170,000
for the Financial Aid Subsidy Program. Titled
"A Night at the Cabaret," the event focused

on student performers and speakers and the increased need for support of arts education programs. Those who attended the event stated it was a unique experience, and some have already placed reservations for the 2024 Gala!

The 2023-2024 Program Season will showcase a new partnership with the Georgia Symphony Orchestra, a returning partnership with ArtsKSU, a variety of field trips, two technical theatre workshops, and the Sweet 16 production of the Georgia High School Musical Theatre Awards.
